**ACCEPTANCE OF MARES FOR BREEDING**

Prior to the semen shipment, the Mare Owner will furnish the Stallion Owner with a copy of the Mare's Registration Papers and a Veterinarian's Certificate certifying that the Mare has been examined and is in good health and condition to be bred. Mare Owner acknowledges that the Mare will be bred by a qualified professional and in a clean environment.

The Mare Owner agrees to make every effort to ensure that the Mare is ready to breed. In the event that Mare does not take and become in foal, Mare Owner agrees to pay \$200 for additional Stallion Service Fee for each additional collection and shipment of semen.

Semen will normally be collected on Monday, Wednesday or Friday, and where possible, shipped for arrival on the following day, which would be Tuesday, Thursday or Saturday. Stallion Owner agrees to ship semen by Priority Overnight Delivery. A minimum of two inseminations will be included with each shipment.

**LIMITATION OF LIABILITY**

The Mare Owner will hold the Stallion Owner harmless if for any reason the Mare does not become pregnant, and for any disease, accident, sickness or death of the Mare or her foal.

Should the Stallion die or become unfit for service, the Mare Owner shall have the right to a refund of the Stallion Service Fees. The Stallion Service Fees are the only fees or expenses that are refundable or will be reimbursed by the Stallion Owner.

**LIVE FOAL GUARANTEE**

In the event that the Mare produces a foal that dies within two days of foaling, and the Mare Owner furnishes a veterinary certificate stating this within fifteen (15) days of the foaling date, Stallion Owner will offer a refund of the Stallion Service Fee less \$200 deposit, or a breeding to the same mare within one year after the foal dies. If the Mare Owner fails to provide this veterinary certificate, no refund of the Stallion Service Fee shall be due for any reason, and the contract will be voided. In the event that the Mare is sold or changes ownership, any refund of the Stallion Service Fee shall be voided.

**REPRESENTATIONS**

Stallion Owner represents that any semen transported will be from the Stallion indicated on the Semen Collection Report, and that information on the Semen Collection Report will be accurate. Mare Owner represents that all applicable Mare and personal information provided to the Stallion Owner will be complete and correct.

**ENTIRE AGREEMENT**

This document constitutes the entire agreement between the parties. This Agreement may be amended or modified only in writing and signed by both parties. Any communication made in connection with this Agreement will be made in writing. This Agreement shall be governed by laws of the State of Texas.
